Between two jobs and four kids, Angela Willson has little time to spare. So Willson figures she should be able have the option of voting absentee in elections---without giving a reason. "Allowing all registered voters to choose to vote absentee would make my life a whole lot easier," said Willson, a nurse anesthetist from Grosse Pointe Park. "And it would help our state line up with 37 others that allow all registered voters to cast their ballots on or before Election Day."

Willson made her comments on January 22, 2018 at the kickoff for **Promote the Vote** campaign, an effort to place on the November ballot a constitutional amendment to provide comprehensive election reform for Michigan. Citing the need for an accessible and secure ballot for all, a coalition which includes the League of Women Voters, the ACLU of Michigan and the state and Detroit branches of the NAACP filed ballot language Monday with the Secretary of State's office, organizers announced.

In addition to no reason absentee, the amendment would give military members more time to vote; let citizens register closer to Election Day; allow straight party voting, automatically register citizens when they do business at the Secretary of State's office, protect a secret ballot and add audits for election results. The group called the reforms "common sense" designed to give more individuals a secure and accessible ballot. "We're all better off when more Americans---Republicans, Democrats and independents---participate in our democracy," said Judy Karandjeff, president of the League of Women Voters of Michigan. "Providing a system that works for all isn't hard; it just common sense."

The changes mirror reforms enacted in 40 states that make voting more accessible. Once the ballot language is approved, the coalition has to collect approximately 316,000 signatures to get the measure on the November ballot. "Putting voters first means making sure that our system is fair and has integrity," said Ismael Ahmed, a longtime community activist. "Under this amendment, our votes would be protected because our elections could be audited."

Updating the voter rolls and making the system more secure is good news to Michelle Mills, who had to cast a provisional ballot in 2017 because of inaccurate information at her polling site. "We need a system that works for all," she said.

1918 TEA

Although the weather was rainy and cool it did not stop folks from coming out to our first fundraiser, the 1918 Tea. About 50 people came out on April 17th for tea and desserts and to hear from our guest speaker, Elizabeth A. Homer. Ms Homer is a teacher, historian, author and a former director of the Michigan Women's Hall of Fame in Lansing. She told us some great stories about the fight for women's right to vote in Michigan and also some of her experiences with educating people on women's history in Michigan. We had a number of elected officials attend including Ms. Corinna Guererro, New Haven City Clerk, Ms. Kim Meltzer, Clinton Township Clerk, Ms. Denise Mentzer, Mt Clemens City Commission, Mr. Henry Yanez, Michigan State Representative for the 25th District and Mr. Steven Bieda, Michigan State Senator for the 9th Senate District. Additionally, Senator Bieda presented the League with a Special Tribute Celebrating the 100th Anniversary of Women's Right to Vote in Michigan.

LET IT BE KNOWN, That it is both a pleasure and a privilege to commemorate the 100th anniversary of women's voting rights in the state of Michigan. On November 5, 1918, Michigan women obtained the right to vote in state elections, prior to the ratification of the Nineteenth Amendment that granted women's voting rights at the federal level.

Founded in 1919, the League of Women Voters is an organization which encourages citizens to be informed and knowledgeable about governmental and public policy issues. Members of the League of Women Voters study issues and distribute information on candidates and on a variety of topics to create a more aware voting public. Form the local to the state and national levels, the members of the League of Women Voters have exerted strong influence for voter participation in the political process and informed political action, and we are proud to honor

VOTER EDUCATION & VOTER REGISTRATION

As the nation's largest and longest-standing grassroots voter registration organization, the League of Women Voters (LWV) works year-round to make sure all eligible Americans have the opportunity to register and vote. The LWV Macomb unit has been actively working voter registration this summer.

We have had a table at the Warren Farmer's Market this summer on each Sunday morning from 9 a.m. until 2 p.m. We are registering voters; passing out voter registration forms and absentee voter forms; answering questions; and educating people on the Ballot Proposal *Promote the Vote*. Recently, we have started educating voters on Proposal 2, the Voters Not Politicians ballot proposal to stop gerrymandering. On August 20th and 21st the Macomb LWV unit had a table at the Macomb Community College Central campus during Welcome Week. We passed out information about the League, (online voter guide) and educated students on the two ballot proposals on gerrymandering and voting rights.

On the same day the Macomb LWV unit joined with the Warren City Clerk's office at a table at the Macomb Community College South campus. We passed out information about the League and explained <u>Vote411.org</u>. We were also allowed to register voters and accept absentee voter applications. We registered 61 students. The students were very receptive to having us there. We offered a fast and friendly way to register to vote and get their voting questions answered. The event was so successful that we have been invited back for the October Fall event on October 3rd.

The next Welcome Week at MCCC is January 7th and 8th, 2019. We intend to register voters at south campus. Only an employee of the Clinton Township Clerk's office, who is a deputized Election Official may register voters at MCCC center campus. We need to identify any LWV member who is an election inspector in Clinton Township or is willing to become an Election Inspector or is currently employed by the Clinton Township Clerk's office. Please identify yourself to Laurie Artz if you meet this criteria and are willing to register voters at center campus.

Vote411.org (online voter guide)

Our Macomb County MAL Unit covered Vote411 for the Michigan 2018 Primary election by sending a series of questions 59 total candidates running for:

- Macomb County Executive (4 candidates, 2 Republicans, 2 Democrats)
- Macomb County Clerk/Register of Deeds (17 candidates, 11 Republicans, 6 Democrats)
- All 13 of the Macomb County District Commissioners (38 candidates)

We received 25 responses which is not quite 50%. This response rate was actually pretty good but I think we should take it as a challenge for us to do more follow-up with the candidates. The Vote411 team can do that formally but it would also be great if all our members who notice candidates that did not respond would contact them directly and ask them why they didn't feel it was worth their time to provide information to the constituents! Tell your friends and neighbors also. There will be an opportunity to do that again with the General Election - let's get these candidates to be responsive to the electorate!

JUST FOR FUN



Subtitle: "The United States Senate Declared Against Woman Suffrage October 1st 1918."

How far have we come?

Why Not Let Her Vote?

Time has come when Michigan should give Women the right which belongs to her.

On Tuesday next the electorate of this great commonwealth has the privilege to extend to women the right to vote. This right will be accorded her in due time if a majority of the voters mark a cross after the amendment of our constitution according her the franchise which rightfully belongs to her.

There are some questions presently to the voters that are worthy of debate. Sometimes the voters are quite at a loss to know or at any rate to realize just what would be better to approve or disapprove. The question of amending our state constitution to accord women the right of franchise on par with men should demand little discussion at this time. Woman has shown herself, in so many ways, to be worthy of the ballot that it would be grossly unfair and unjust to longer deprive her of it.

Michiganders pride themselves of their progress and usually on well founded claims. We cannot then, any longer, lag behind several other states in this great Union of ours by with holding the right of women to vote along with their husbands, fathers, brothers and many others some of whom it would seem are much less capable of exercising the privilege of the franchise than so many of our women folks.

So on Tuesday next let us consider what the women's place is in the affairs of this commonwealth, what she has done and is doing to help the state and country all that we can hope for and rightfully deserve. Let us by an overwhelming majority at the polls place Michigan in the class with those other sister states which have removed the ban and gives unto womenkind what she should not be obliged to ask for, but should have been granted long ago. Vote Yes for the amendment to Section One of Article Three of our constitution.
